

2019 Victorian Caravan, Camping & Touring Supershow 'Buy a Recreational Vehicle and Win a Big Red Bash Experience'

Conditions of Entry

6. Entry must be completed online on the official form, all sections completed and correct promo code entered to be eligible. All entrants must retain evidence that they attended the 2019 Victorian Caravan, Camping & Touring Supershow and purchase details will be confirmed with recreational vehicle supplier.
